We precision cut our 2mm thick, crystal clear acrylic to the internal dimensions of the box frame and then seal the print and acrylic fascia into the frame. The frame itself has a 22mm wide lip which gives your image a clean, stylish outlined finish.

OUR TERMS
- 1.1

These Terms are the terms and conditions on which we supply Products to you, whether these are goods and/or services.

When we use the words “writing” or “written” in these Terms, this includes email.
- 4

OUR CONTRACT WITH YOU
- 4.1

By placing an order through our Website, you are making an offer to purchase our Products in accordance with these Terms. Our acceptance of your order will take place when we email you to accept it, at which point a Contract will come into existence between you and us.
- 4.2
